1. Call to Order

The Quality Workforce Committee was called to order at 1:02 P.M.

2. Welcome/Introductions

Welcome was provided by Committee Chair Mark Gaspers.

4. Call to the Public

5. Presentation: Arizona Apprenticeship Programs

William “Willie” Higgins, State Apprenticeship Program Lead, Employer Engagement Administration, Department of Economic Security

Willie Higgins from the Department of Economic Security provided an explanation of registered apprenticeships to the Committee. He spoke briefly about targeting specific sectors and provided a high-level overview of the Apprenticeship Office’s approach in each targeted sector.

Willie explained how the Apprenticeship Office works with employers to begin programs. The Apprenticeship Office currently coordinates 114 programs in AZ, goal is 200 by the end of the year.

Willie explained some of the Apprenticeship Office’s current challenges and there was a brief discussion with Committee members.

6. Presentation: Business Services Training

Monica Magoon, Workforce Program Manager, Office of Economic Opportunity

Monica Magoon of the Office of Economic Opportunity provided an update on Business Services training. Monica explained how the Department of Labor is using Technical Assistance funds to provide training and has engaged a third-party firm to design the

training and spoke to the use of Advanced Strategy Lab to facilitate surveying of businesses.

7. Presentation: Advanced Manufacturing Corridor (Update)

Rosalyn Boxer, Workforce Program Administrator, Office of Economic Opportunity

Keith Forte of the Office of Economic Opportunity presented on behalf of Rosalyn. Keith provided a brief historical context of the project and an outline of the outcome of the project implementation. He also spoke briefly regarding the project funding process, including an update that the project had secured funding from the Governor's Office and is currently negotiating contracts.

8. Committee Next Steps

Committee members were encouraged to forward next steps and new ideas to the Council Manager.
