## V. Director's Report

## Patricia Ray Reported:

- Patricia Ray welcomed everyone and wished them a Happy New Year.
- Patricia briefly explained that the board is paperless and has moved onto the electronic age. Starting next month the board meeting will be available via conference call and Go to Meeting. The new technology will assist with ensuring a Quorum is met at each meeting. Board members who can't attend will have access thru their mobile device and computers. However, board members are encouraged to attend in person as much as possible.
- Patricia Ray introduced the following new board member:
  - Randy Etzler Chief Human Resources Officer from Yuma Regional Medical Center; and
  - Anne Powell Vice President/Executive Banking Relationship Manager for National Bank of Arizona
- Patricia informed the board that the Martin Luther King (MLK) Center was on the front page of the Yuma Sun on December 2017. She attended a Citizen's Forum held on at the Yuma City Council on December 19, 2017 accompanied by Thelma Lundy where Norma Nelson, President of the NAACP addressed lack of diversity of services at the MLK. Patricia answered several questions from Councilman Mike Shelton and Mayor Doug Nicholls regarding the center. Patricia explained how staff goes above and beyond to provide different services to the community. On Friday, January 5, 2018, Patricia met with Ms. Nelson and two members of her family, two City staff and two youth staff members but nothing was resolved.
- Board member Sam Pepper provided a brief history of how the MLK Center came part of the Yuma Private Industry Council.
- The following were some of the board members suggestions:
  - Patricia and a couple of board members meet with the Mayor Doug Nicholls and Greg Wilkinson.
  - Create a PR Committee to help market the type of services the MLK center offers in order to educate the community.
  - o Come up with a plan in case the city decides not to renew the lease in 2021.

- Meet with Norma Nelson at YPIC Administration and provide a presentation on the type of services the center is authorized to by law to offer to the residence of Yuma County.
- o Invite Norma Nelson to be part of the board should there be a vacancy in the future.

## C. Charter High School Board, Report

Ed Ford reported:

- Attendance is at 110%
- Enrollment is at 90.25%
- The school had 11 graduates for Quarter 2.
- The Charter High School is currently at 49.25% for the total expenses and 50% of the fiscal year. The school is right on budget.

## D. JTED, Report

Kevin Imes, reported

- JTED stand for Joint Technical Education District. There is currently a bill that is going forward this session to change the name to Career and Technical Education District (CTED). More information will be provided in the future.
- STEDY is currently collaborating with Arizona Western College (AWC) on Health Career Workforce Project grant. The grant will allow adding new programs such as Lab Assistant and Medical Assistant program. Computer Animation Program is a new program that will be offered which will go hand in hand with the Coding program.
- Mr. Imes was happy to report that Maricopa County has been asking how the STEDY program is able to collaborate and partner with the folks in Yuma County since they have not been able to do so.
