The states received estimated numbers from DOL on Title I and Title III funding the day the bill was signed.

A. National Association of Workforce Boards Forum

Patricia Ray Reported:

 Maria Chavoya and Patricia Ray traveled to Washington DC from March 24th to March 28th. The conference is specifically for Directors and Workforce Board Members and has a variety of workshops and legislative updates related to WIOA. • This year the Governor of Colorado spoke about their workforce skills programs and the apprenticeship program they have developed after highly successful model in Switzerland.

• Maria Chavoya, Dave McDowell, Ed Ford and Patricia Ray met with Greg Wilkinson, City of Yuma Administrator to discuss the MLK lease on Friday, March 30th. - The EOC Charter High school has been added to the Yuma Union High School District Level 1 Emergency Notification System.

D. STEDY, Report

• The STEDY Board has approved the STEDY move into its new building. As of July 1, 2018, STEDY will be located at the former University of Phoenix building located at 899 E. Plaza Circle in Yuma.
