Patricia Ray reported;

- Patricia Ray introduced Beatriz Aguilar as the new Clerk of the Board.
- Patricia Ray introduced the potential board member, Valentin Casillas, from the Arizona Department of Economic Security. He will be replacing Eulalia Tinoco.
- Patricia Ray welcomed Tim Tucker from the Arizona Department of Economic Security.
- Staff from the Arizona Department of Economic Security (DES),
 Department of Employment and Rehabilitation Services (DERS) will
 be having a conference call with DOL Region 6 Representatives to
 negotiate performance measure goals for the Fiscal Year 2018 and 2019
 today at 10:00 am. The Yuma County Workforce Board staff has been
 invited to listen in on the call. Staff participated in a conference call last
 week to go over the performance measures for the current year and to
 assist the DES/DERS staff with information from the local areas for the
 negotiations. Patricia was pleased to announce that Yuma County is
 currently meeting these measures for the current year.

- On April 12th, YPIC hosted the seminar in Excellence Employer
 Engagement/ Business Services training in Phoenix. Approximately 50
 people from across the state attended the training. The evaluations

 additional information which will assist them with their jobs.
- Arizona@Work-Yuma County Core Partner staff will identify

 neighborhood to meet their workforce needs. Core Partners will be
 meeting with Housing Authority staff on May 10th to discuss a schedule
 to provide the workshops and services at the Mesa Heights Community
 Center when it opens in the Fall.
