VI. Director's Report and Information Items

A. Washington update:

- Reauthorization:
 - House introduced 3 Republican Bills
 - There seems to be enough Republicans that would support a locally driven system
 - The window of opportunity to get WIA reauthorized this year is very small- if it is not done by April- it probably won't be done.

- House Democrats are circulating a bill (Miller-Tierney), but will need Democratic co-sponsors. The bill will be introduced by the week of January 23rd.
- Appropriations will start in late February and March- House will be tough on domestic spending.
- Fear of sequestration still there (50% across the board cuts) through 2020.

B. State Update

- John will be attending a Governors Council of Workforce Policy Executive Committee meeting tomorrow in Phoenix; working on sector strategies.
- We will be utilizing a new data system soon; we are having some problems with the conversion of data. Details are being worked out.

VIII. Other Information and/or Committee Reports Economic Development

Julie Engel reported:

- -Insultech is currently occupying a building on Factor Avenue but is considering moving to the old Russell Coil Building.
- -The Secure Electronic Network for Travelers Rapid Inspection (SENTRI) lane in San Luis Rio Colorado, Mexico was fenced and the traffic had to be redirected across the normal lanes which caused delays in getting across the border. The speculation is that there are plans by the federal government to attempt, one more time, to open a toll booth for the SENTRI lane users.
- -Submitted proposals on behalf of four companies for grant available through the Arizona Commerce Authority- for rural areas.

-A big issue for large businesses to choose Yuma is the lack of a large industrial space that can accommodate 100,000-300,000 square feet. Plans to address this issue include the development of a virtual building suited for new businesses needs. The space will be ready to move in approximately six months. This would reduce the time for building and having to go through all the red tape that is normally necessary.
