A. Washington update

John Morales reported:

- Republicans still have control of the House
- In the Senate Democrats picked up three more seats
- Two major issues going on now until January 2nd: Avoid the Fiscal situation (taxes will go up on January if no action is taken by Congress); the other issue is sequestration: for WIA it would be a reduction of about 8.2% in funds- this would occur every year for the next ten years.
- Besides the sequestration, on the workforce side we may be in good shape.

B. State Update

John Morales reported:

• Attended the Governor's Council on Workforce Policy

meeting in Thatcher, AZ last month. It was the last meeting of the Council as we know it.

- The Governor has called for a new smaller Workforce Council.
- The next meeting of the Council will be on January 2013.
- Two names were submitted from Yuma to hopefully be a part of the Council.

VIII. Other information and/or Committee Reports Economic Development

Julie Engel:

- Spoke of some significant facts of the Yuma area:
 - o Agriculture industry is shrinking in the area;
 - Yuma is shifting their focus to the aerospace/defense industry;
 - Military leaving active duty have skill sets needed in aerospace industry but they need the certificates; looking at Embry Riddle to provide those certifications with assistance from Arizona Western College;

- There is a perception that solar industry is not creating jobs because they are not permanent jobs; however, the construction side of it is very valuable. It has a positive impact and it is creating jobs for people who live here and can commute a short distance.
- Toured a virtual call center company last week- they are willing to make the investment on the home (broadband and equipment) and they will provide healthcare.
- Nation's Health has secured new contracts; they will need to ramp up to the 700 mark much faster than anticipated.
- There is an opportunity for property that is a produce facility; there are companies that can be utilizing that property if it is available.
- Annual report is available on the GYEDC website or you can stop by their office.
- There is an opportunity to market a property for a production company.
- Introduced Ben Bronson from Arizona Commerce authority; he is the new manager for Rural Development/Arizona Commerce Authority.
