## VI. Director's Report and Information Items

### A. Washington update

John Morales reported:

- Representative Raul Grijalva introduced Bill HR 546 to amend the Workforce Investment Act of 1998.
- Workforce Committee Chair John Kline and Virginia Foxx are also working on the bill that she introduced last year.
- Bipartisanship in the House remains elusive.
- We are hoping this year the Workforce Bill will be reauthorized.
- Many believe that sequestration will go through.
- Optimists believe there will be a large deal crafted at the last moment to avoid sequestration.

### B. State Update

John Morales reported:

• We have been working with State officials on

Credentialing.

 On the first week of March, Department of Labor will provide guidance on credentials via web conference.

# D. Update on State Plan

- The new State indicates that by June 30, 2013 there will be functional integration of WIA and DES staff. Employment Services (ES) staff will be relocating to YPIC's Career Center; ES staff will be assisting with core services.
- The Business Services staff will also integrate. A meeting
  was held yesterday, and partners are coming together. Greg
  Newton Associates will be providing training related to
  Business Services for the State; YPIC will also contract
  with Mary Ann Lawrence, who wrote the state plan to
  provide training.
- Partner agencies that are not Employment Services or WIA staff, will need to be fully committed to this project; they will need to move at the speed of business
- Clear expectations will be outlined for YPIC and DES staff.
- Staff will receive initial and ongoing training to ensure capacity building.
- This type of integration is crucial and we have to make it work. Kim Rodriguez and John Morales are committed to make this work.
- The whole idea is that a business will receive services in a manner that is systematic, professional, and seamless.

### **E.** Update on Partners Meetings

- There will be a partners meeting on February 21<sup>st</sup>.
- We meet on a quarterly basis, and share valuable information.
- Last year, the Natelson Dale Group conducted a study pertaining to Rapid Response; the group will be present at the next partners meeting and they will explain the study.

## F. Labor Availability Survey

- We have an RFP out but the funds may not be available due to pending sequestration.
- It would be a very useful study but we are "putting the brakes" on it since it may cost more than anticipated.

### **Economic Development:**

Alison Morey reported for Julie Engel:

- Project 1: California Strategy- Utilizing the Sun newspaper and GYEDC's newsletter to target businesses in California that meet certain specifications, to bring them to Yuma. Looking specifically for community involvement to provide contact names of those in the business that are able to make decisions.
- Project 2: Geographic Information System tool shows the buildings and land available in Yuma County; it also has a lot of information in Yuma.
- Project 3: Meeting tomorrow to discuss the future of Yuma County in relation to renewable energy for the next five years with Yuma County and U of A.

John Morales asked Alison to please congratulate Julie- two companies were recipients of grants to rural areas thanks to Julie's efforts.

### **Finance and Personnel Committee**

• The committee met yesterday to review the 990 Tax Form; if

- The committee also reviewed mid-year financial reportseverything is in order.
- The committee spoke of the possible scenarios if sequestration takes place. We are looking at 8.2% funds cut we do have carry over funds and we will be OK this year...however, the following year and thereafter we may need to make adjustments.
- The committee talked about the benefits of utilizing a Return on Investment business model tool, to ascertain the benefits of investing in training. YPIC will work on this project.
- The committee also talked about the possibility of YPIC developing a cost per participant model that will provide estimated expenditures amounts. YPIC will work on this project.

### **Charter High School:**

Ed Ford *reported*:

- The EOC Charter High School Board met previous to this meeting.
- Enrollment is at 105; attendance is at 90.5%.
- There was a discussion of the possibility of replacing the school doors with steel doors, or installing deadbolts on the doors currently in place. It was decided that it would be more cost effective to install deadbolts.
- The financial reports were reviewed, it is slightly above budget but very manageable.
