A. Washington update

John Morales reported:

- The SKILLS Act was introduced by Rep. Virginia Foxx. It
 consolidates all training programs, gives the Governor the
 authority to make decisions on how the local areas are
 designed. The bill does not have bi-partisan support. It is not
 likely to be passed by the Senate.
- The effects of sequestration will be felt after July 1st, 2013; YPIC has already budgeted accordingly.

B. State Update

John Morales reported:

- The members of the new Workforce Arizona Council (WAC) have not been announced yet.
- The new members, after being selected, will need to receive training, and an overarching set of policies need to be developed.

 The State of Arizona will be asking Department of Labor for a waiver to move to the Six Common Measures, instead of the current 17 performance standards. Comments are being accepted right now.
