VI. Director's Report and Information Items

A. Washington update

John Morales reported:

• The SKILLS Act was introduced but does not have bi-partisan support. It was passed by the House, but it is not likely to be passed by the Senate.

• Due to sequestration, the local WIBs will get the first reduction of funds on the first quarter of the next fiscal year. YPIC has a carryover that will allow us to continue services on this quarter (July, August, and September 2013).

VII. Discussion/Action items

A. Approval to sign the lease and sub-recipient agreement for the Martin Luther King Center with the City of Yuma.

Julie Engel reported:

- There was a Craft Talk session at the Yuma Executives Association meeting yesterday. Patrick Goetz made an excellent presentation and invited everyone to visit the MLK center.
- Working with a company that is looking for a black belt trainer in Six Sigma.
- Obama administration has released funds (32 million) for economic development grants. June 13th is the deadline. University of Arizona

has asked Yuma to partner with them. The focus is on manufacturing/business/infrastructure needs; Yuma will focus on infrastructure shortfalls.

Finance and Personnel Committee

- A. The committee met on Monday, May 6th.
- B. Items discussed were:
- Rental of the Martin Luther King Center: YPIC had presented this
 possibility to the committee at a previous meeting. At that time, the
 Finance and Personnel Committee asked YPIC to do its due diligence
 and present the item again at a future meeting. YPIC presented the
 item on Monday at the meeting, and all questions were answered
 satisfactorily.

- 3. Eligible Trainer Provider List Committee: YPIC asked the committee for assistance in the future when making the final decision regarding the approval of new providers and training programs to be listed on the Eligible Training Provider List.
