AYW Committee Members collectively agreed that incorporating discussion of youth and parent recruitment would be a valuable agenda item for the next committee meeting on 11/27/18. Christina Edwards, Phoenix Business and Workforce Development (PBWD) Board Liaison, confirmed that State requirements are currently being met and efforts are being made to better align Board Bylaws with AZ Department of Economic Security requirements. with the assistance of LaSetta Hogans, PBWD Board Executive Director. Jeff Kulaga, Vice Chairman, suggested that each AYW Committee Member bring two resources for recruitment of youth member involvement to the next AYW Committee Meeting on 11/27/18. Mark Carr, Committee Subject Matter Expert, stated that staff will communicate with current youth service providers to request youth nominations. Katherine Pappas, Pipeline AZ, discussed resources available to assist in development of career exploration guides referenced within Year 2 Goals. LaSetta Hogans, Phoenix Business and Workforce Development (PBWD) Executive Director, explained how career exploration guides are a joint focus of the AYW Committee and Service Delivery Committee in developing a mechanism to educate youth and adults of various career pathways. Cynthia Spell Tweh, Deputy Human Services Director - City of Phoenix, emphasized the value in collecting and educating job seekers on career pathways.
