1. Call to Order

The Performance Excellence Committee was called to order at 1:01 P.M.

2. Welcome

Chair David Martin welcomed everyone in the room to join the Committee at the Conference table. He framed the meeting as an informal discussion with those present to learn more about the role of the Performance Excellence Committee.

3. Call to the Public

There were no comments made by the public.

4. Approval of Minutes

Naomi Cramer moved to approve the minutes from the February 8, 2018 committee meeting. David Martin seconded, the minutes were approved.

5. Approval of Local Board Certifications

Gretchen Caraway from the Department of Economic Security, DERS provided a brief background on local board certification and reminded the PEC that the full Workforce Arizona Council had provided them the ability to vote on final approval for the local area boards not approved at the March 1 WAC meeting. Gretchen proposed final approval for Maricopa board, Pima Board, and Yavapai board, assuring the committee that appropriate measured had been taken to address deficiencies by each of those local areas. Gretchen did not propose final approval for the Nineteen Tribal Nations Local Area.

a. Vote for Final Approval of Local Board Certifications

Naomi moved to provide final approval for Maricopa County Board, Pima County Board, and the Yavapai County Board. Dennis Anthony seconded. Motion passed.

6. Council Overview

Council Manager Ashley Wilhelm provided a brief background on the Workforce Arizona Council, including an overview of the Federal law that mandates the existence of the board. Ashely provided an overview of the functions of the state board, including creation of a 4-year plan, creation of statewide policies, continuous improvement elements, accountability measures, identification and dissemination of best practices, strategies for technological improvements, allocation of funding from the Federal level, preparation of an annual report, and the development of an labor market information system.

a. Committee Overview

Ashley outlined the role of the Performance Excellence Committee as the policy-development arm of the Council, responsible for ensuring an effective system statewide.

7. History of Performance Excellence Committee Activities

a. Policies

Ashley provided a brief overview of the seven policies developed by the Performance Excellence committee. Policies were passed by a previous committee make-up and are, at any time, amenable by the current PEC/WAC. Chair David Martin welcomed anyone to bring to the committee through Ashley suggestions for improvements/amendments to WAC policies.

8. Core and Program Partners

a. Title I-b

Patricia Wallace, Executive Director of the Maricopa County Workforce Board provided an outline of the services provided under Title 1 of the Workforce Innovation and Opportunity Act. Patricia outlined that local boards are included under Title 1 and outlined the responsibilities of the local boards. She also spoke about the operational role of Title 1, including Adult, Dislocated Worker, and Youth programs.

b. Title II

There was no discussion regarding Adult Education/Title II, since there was no representative present at the meeting. Discussion regarding Title II is tabled until a future meeting.

c. Title III

Christian Espinoza from the Department of Economic Security explained Title III, which is known as Wagner-Peyser. Wagner-Peyser services include employment services, career services, and job search assistance. Christian explained that Title III operations commonly see individuals who are "job-ready", as opposed to Title I operations, which include job training. Christian commented that Title III staff help input customers into the job system, called Arizona Job Connection.

d. Title IV

Kristen Mackey of the Department of Economic Security, Rehabilitative Services Administration provided an overview, including background information, of

rehabilitative services. Kristen mentioned that the workforce component of rehabilitation services is focused around Vocational Rehabilitation (VR). Kristen spoke briefly about the eligibility requirements and the populations that VR serves. Kristen also noted that VR works with employers to navigate how they can work with employees with disabilities.

e. Office of Economic Opportunity

Ashley provided a high-level overview of the Office of Economic Opportunity. Ashley mentioned that the office is comprised of different teams, including the Workforce team (by which the Workforce Arizona Council is staffed), the Data Analysis/Economic Analysis team, which provides data, and the Data Collection team.

f. Division of Employment and Rehabilitation Services(DERS) Policy Program

Gretchen Caraway of the Department of Economic Security explained the role of the DERS Policy team as a group that writes policy that guides work within DERS. Gretchen mentioned that all Titles of WIOA are administered through DERS, with the exception of Adult Education/Title II. Chair David Martin likened the Workforce Arizona Council as a facilitator of investments, while staff implements as agents of the Council. Gretchen mentioned that while OEO/DES implement the Council's vision, they are accountable to other parties as well. Gretchen provided an overview of her team's role as the development of the state plan, the development of MOU's and Infrastructure Funding Agreements (IFA), writing operational policy/guidance, providing technical assistance as needed to local areas, monitoring, and quality assurance. Gretchen also explained the Employer Engagement Administration at DES/DERS.

g. Division of Employment and Rehabilitation Services(DERS) Monitoring Program

Jacqueline Butera of DES/DERS provided a high-level overview of the programmatic audit/monitoring provided by DERS. She stated that most audits are desk-reviews, however, there are some on-site audits conducted by her team. Chair David asked if normal reporting to the PEC from the audit team is possible. She also mentioned that DES/DERS maintained a fiscal audit/monitoring team as well.

h. Business Services

9. Review and Amend 2018 Committee Charter

Chair Martin stated that there was no need to amend the Committee's charter at that time. He asked committee members to review the charter with the knowledge they learned that day.

a. Vote to adopt 2018 Charter as amended No vote.

10. Committee Next Steps

Chair Martin asked committee members where they'd like to see the committee go. Comments included facilitating/highlighting what local areas/boards need to do to be granted final approval and reviewing audit results from the DERS audit team, in addition to receiving feedback on WAC policies.

11. Adjournment

Naomi moved to adjourn, seconded by Dennis. The Performance Excellence Committee was adjourned at 2:53 P.M.
