1. Call to Order

Dawn Grove, Committee Chair called the Executive Committee meeting to order at 1:00 P.M.

2. Welcome

Committee Chair Dawn Grove provided welcome to Executive Committee Members and quests.

3. Chair Report

Dawn discussed the new Open Meeting Law rules with the executive committee. Dawn stated that she had nominated Ashley Wilhelm for the Gabe Zimmerman Public Service Award for Emerging Leaders.

5. Approval of Minutes

Mark Gaspers moved to approve the minutes, David Martin seconded the motion; the motion was adopted.

6. WIOA Waiver Requests

Karen Hunter Douglas, WIOA Coordinator for the Arizona Department of Economic Security discussed the two waivers with the Executive Committee.

a. Individual Training Accounts

- i. 434 impacted youth in Arizona requests approval to waive the requirement under 20 CFR 681.550 allowing use of ITAs to only Out-of-School Youth for attending training programs on the ETPL. Arizona requests ITAs also be available to In-School Youth so they may attend training programs on the ETPL.
- **ii.** David Martin moved to accept the waiver and to get it sent to DOL, Mark Gaspers seconded the motion; the motion was adopted.

b. WIOA Title 1-B (ETPL)

- i. Arizona needs enhancements to AJLA to support the WIOA ETP Annual Report, as the system is not currently capable of collecting performance data from training providers. Therefore, Arizona does not currently have the data to support performance thresholds.
- **ii.** Arizona will be joining the 19 other states that have requested this waiver.
- **iii.** David Martin moved to accept the waiver and to get it sent to DOL, Mark Gaspers seconded the motion; the motion was adopted.

7. WIOA PY19 Funding Allocations

- a. This years' allocation from DOL has increased to \$80,142,523. Arizona's share of total WIOA Title I funding is roughly 2.7%. Economic Momentum in Arizona is strong, but relative to other states, the funding formula factors did not improve as much. Youth and Adult increased by 15.7%, Dislocated Worker increased by 30.1%, which was a total increase of 20.8%.
- b. Mark Gaspers moved to approve Title I-Adult Option 2, Title I-Youth Option and Rapid Response Option 4 allocations and to have the dislocated worker allocation reviewed again by DES & OEO along with the LWDA Representatives to see if they can come up with a better option and have it ready to present to the WAC on June 5th. David Martin seconded the motion; the motion was adopted.

8. Discussion: 2020-2024 State Plan

Karen provided an update to the process that will be utilized for the State Plan, she also provided the Current Vision for the State Plan along with the Governor's state priorities. Council members asked a few questions about the State Plan process for Arizona, all questions were answered. Dawn thanked Karen for the report.
