
5. Client Referral System Presentation

Stacey Van Emst, One Stop Operations Manager, gave an update to the Board on creating of a Client Referral System (CRS) for City of Phoenix WIOA partners to us when referring customers for services.

Stacey shared that the WIOA vision is to strengthen and improve our nation's public workforce system and help get Americans, including youth and those with significant barriers to employment, into high–quality jobs and careers and help employers hire and retain skilled workers. WIOA facilitates integrated partnerships that seamlessly incorporate services for the common customer Job seeker employment services can be provided by a "direct linkage" through the technology to provide meaningful services or information. Direct linkage is more than simply handing someone a flyer or phone number.

The CRS will strengthen partnerships by learning about all program services easily and efficiently within the partner network and leverage resources to increase the number of co-enrollments to provide the most comprehensive services to customers. There is no wrong door we are all WIOA we are all ARIZONA@WORK.

The CRS flow chart was shared with the Board members.

6. Capstone Project Presentation

Ricky Duran, City of Phoenix Business and Workforce Development Division, Data and Research Manager, gave the final presentation on his capstone project, *Aligning Workforce Development with the Needs of the Community: A preliminary geographic analysis of community needs and resources within the city of Phoenix.*

The objective of the project was to ensure that the City of Phoenix's workforce development efforts align with the needs of the communities we serve.

Project Goals:

- Better understand the distribution of needs and barriers to economic success across City of Phoenix communities.
- Establish a foundational framework for future efforts to better understand and serve the City of Phoenix workforce.
- Develop next steps and workable recommendations to better align workforce resources and services with the needs of the community.

Ricky shared in-depth information regarding populations with barriers to employment within the City of Phoenix, such as: Worker Disengagement, Living in Poverty, Limited Education, Homelessness, Internet Access, Single-Parent Families, Foster Youth, Veterans in Poverty, Disabled and Unemployed, English Language Learners, and Re-Entry for Ex-Offenders.

Next steps include:

- 1. Conduct same analyses of Census 2020 Data (Expected Summer 2021)
 - Increased accuracy
 - Recent data collection
- 2. Compare with City of Phoenix WIOA Program Data
 - Inform current processes
 - Highlights accomplishments and opportunities
- 3. Continue efforts to better understand the customer
 - more in-depth research vulnerability characteristics, as well as others, as determined
 - Develop client personas
 - Use personas to inform the development of programming and partnerships

Ricky closed his presentation by stating, "Remember our Customer is a person. By serving the person, and not just the issue, we are able to truly serve the customer, assist them with overcoming their individual barriers and prepare them for successful and sustainable economic engagement."
