4. Business Engagement Updates:

ARIZONA@WORK City of Phoenix Business Services Specialist Christina Quijada shared the Numbers@Work report. The report detailed business outreach and activity for FY 2021-22. Business Services Specialist AI Jernigan shared information about outreach and assistance provided for the Micro and Small Business Grant. Christina shared information about the Workforce Training program, a grant program for Phoenix-based organizations that offer business training programs and/or demonstration projects that can benefit Phoenix entrepreneurs and the small business community.

5. Business and Workforce Engagement Committee Strategic Plan Review: BWEC members to establish a recurring time to meet with their strategy groups and bring information to the July BWEC Meeting.

Strategy Four: Leverage labor market information to inform decisions and strategic impact of Workforce Development

Suggested eliminating "Utilize and report employing BLS, Census, Economic Modeling Specialist Intl. (EMSI), and other available data mechanisms" as an action. The group plans on revisiting which sectors are targeted using Labor Market information (LMI)

Strategy Five: Ensure ROI for Workforce Development in the City.

- **Strategy 4:** eliminate "Utilize and report employing BLS, Census, Economic Modeling Specialist Intl. (EMSI), and other available data mechanisms" as an action

- **Strategy 6:** Change action to "recruit participation once Career Pathway or apprenticeship opportunity is designed"

- **Strategy 6:** change action to "educate employers on resources, including those offered by ARIZONA@WORK City of Phoenix" and changing the metric to "business services team metrics and Bagels & Business outreach"

- **Strategy 6:** Add action "State & regional workforce updates on education investment that leads to Career Pathways" with the metric "Quarterly updates for the strategy group."
