The amount of the contract is Seventy-Five Thousand Dollars (\$75,000.00), federal grant funds, and comes under the direction and authority of the Mohave/La Paz Workforce Development Board, Mohave County, and staff to the board provided by Mohave County's Community Services Department. The Workforce Innovation and Opportunity Act (WIOA) requires the competitive procurement of the One Stop Operator. Two (2) proposals were received and opened publicly on December 21, 2018.
