A. Washington Update

John Morales reported:

B. State Update – State Plan

John Morales reported:

- The Draft WIOA Unified Workforce Development Plan 2016 2020 was posted for public comments.
- The Workforce Arizona Council Task Force prepared an Executive Overview to provide an easy reference for the local areas to understand and implement Arizona's Unified Workforce Development plan.

C. Rapid Response//Business Services Update

- Patrick Goetz from YPIC presented a power point on Rapid Response and Business Services.
- Patrick explained that the Seafood companies are from different States. The seafood industry is becoming a competitive industry. Salary wages have increased from \$8.75 to \$15.00. Employers offer seasonal work for seafood processing worker and helps ease seasonal labor shortage. Companies offer housing accommodation and transportation arrangements.

F. AWC and U of A Engineering Expansion Grand Opening

- Dr. Glenn Mayle spoke about the importance of providing possible engineering students the opportunity to stay in Yuma and become employed as opposed to relocating to another city or State.

- Two members from the Pinal County Workforce Agency visited the One Stop Youth Facility and the Career Resource Center One Stop.
- Pat Ray and Mercy Mendivil took the time to show them the facilities and explained the process. They provided copies of the One Stop policy and procedures.

VIII. Other information and/or Committee Reports

Economic Development:

Julie Engel reported for GYEDC:

- Julie informed the board that it was amazing to see how the community responded to AWC Engineering grand opening and how the community learned about the new opportunities that AWC has to offer. Julie thanked Dr. Glen Mayle for helping create those opportunities.
- The Fifth Americas Competitive Exchange (ACE) Conference will be held on April 13, 2016. ACE will be in Arizona and California. 53 worldwide delegates will be stopping in Yuma to tour the Yuma Center for Excellence for Desert Agriculture, and the Jo Foss Hanger. Dinner will be hosted at the Quarter Master Depot.
- Two food productions companies from California might be relocating to Yuma. More information will be provided in the future.
- Julie provided an update on the Civilian Employment Contract at YPG.

Finance & Personnel Committee:

• The Budget & Personnel Committee did not meet.

Charter High School Board, Report:

Ed Ford reported:

- The Charter High School Board had an informational meeting due to lack of quorum.
- The EOC Charter High School is still trying to put a plan where they are able to add in the results of the State Assessment that their students take and incorporate them to their final grade.

JTED:

Kevin Imes reported:

- The Legislature passed a bill with full restoration of funding for Joint Technical Education Districts (JTED's).
- The local JTED awarded 2.1 Million dollars to Yuma Union High School district and \$200,000 to Antelope Union High School District.
- 35 students are attending the JTED program at AWC. 10 students from the Educational Opportunity Center Charter are enrolled in various programs.
- Kevin Imes is involved with the Summer Works in Yuma program. The program is intended to keep Yuma County teachers during summer recess period with temporary employment to help fill their financial gap.
- The 3C Expo took place at AWC on February 19, 2016. About 1000 freshman attended. The expo was to provide exposure to Career and Technical Education.
- Kevin Imes explained the process of how the money is allocated to the high school district, how the amount is determined as well as what the money is used for.

IX. Good of the Order

Tom Tyree informed the board that 11 student from Yuma were sent to

Phoenix to attend the CodeDay program. CodeDay is a nationwide event where student programmers, can get together and build games and apps for 24 hours. Yuma will be hosting a CodeDay in the near future. More information will be provided at a later date.

John Morales explained the Geo-spatial density map that was provided to the board members. The density map is based on the participant's addresses for those enrolled into our workforce programs. The map also provides information on where the agency needs to conduct further outreach.
