A. Washington Update:

Patricia Ray reported:

- On October 4 6, 2017, Patricia Ray, Mercedes Mendivil, and Alicia Huizar attended the Investing in America's Workforce Capstone Conference in Austin, Texas.
- The national conference aimed to connect businesses, government agencies, nonprofit, financial institutions, academics and philanthropic organizations to:
 - Reframe workforce development efforts as investments, not just social services
 - Attract new resources and leverage existing funding sources
 - o Improve economic mobility and impact for workers.
- The conference was conducted by the Federal Reserve Bank.
- Patricia Ray would like to bring together Yuma County Businesses and Economic Development to talk about what are the skills gaps, business attraction and business retention needs, and training needs. This effort will be to determine what skills are needed for our future workforce.

Audit Reports for the Fiscal Year ending June 30, 2017 were made available to Board members.

VIII. Other Information and/or Committee Reports

Economic Development Issues, Report

Greg LaVann from GYEDC reported:

- Greg LaVann and Patrick Goetz are working with Goodwill on recruiting a Fortune 500 Manufacturing Company to Yuma County. GYEDC was in competition with Phoenix for the project. Last week the company announced that they will be relocating to Yuma. The Company is currently in meetings in Phoenix with growers and developers discussing architectural design.
- Yuma will be receiving \$30 million dollars in capital

improvements on this project, which will create hire 80 jobs averaging \$38,000 a year. Governor Ducey and the Company COE will make confirmation in November with a joint presentation.

Jenny Torres from City of San Luis reported:

- San Luis pedestrian facility was approved for five million by the Federal Government, but recently the amount was increased to six million.
- There will be a ground breaking ceremony on November 7, 2017. Governor Ducey is expected to attend the ceremony.

Finance & Personnel Committee, Report

The Finance & Personnel Committee did not meet.

Charter High School Board, Report

Ed Ford reported:

- Attendance is at 92.03%
- Enrollment is at 114
- The State Charter School Board approved the Charter High School to increase its enrollment from 105 to 110.
- The Board approved a teacher pay stipend of 1.06% of teacher pay for FY2018.
- The school expenses are at 23% and we are currently at 25% of the school year.
- Mr. Tait presented the 2016/2017 Audit as well as the 2016 Tax.
- Eight students are currently enrolled in STEDY.

STEDY, Report

Kevin Imes reported:

 Kevin Imes complimented the individuals who conducted the South West Arizona Town Hall. Data indicated that 21% of youth between the ages of 16-24, are not working or attending school and only 25% between the ages of 25-64 have a 2 year/4 year degree or certification. Mr. Imes congratulated Tom Tyree- Superintendent and Shelly Melon for all their hard work.
