VI. Director's Report and Information Items

A. Washington update

John Morales reported:

- Sequester has been put on hold, budgets will not increase, but appropriators have more leeway.
- WIA still on Continuing Resolution.

B. State Update

John Morales reported:

• The next Governor's Council meeting will take place on early March.

C. Business Plan Update

- The Five Year Plan was submitted.
- Our plan will be the last to be reviewed; there will be a conference call on April 10th to with State officials to receive comments, clarify answers, etc.

D. Rapid Response/Business Outreach Update

- Patrick Goetz from YPIC presented a power point that reported activities in the last month.
- Dave McDowell asked if we can have the number of actual

positions (in addition to the number of job orders) since this would be a more accurate picture of the job market in the area. It was agreed that a line with number of job opening will be incorporated in the presentations from now on.

Regarding the last job fair: 1500 surveys were sent out: 28
employers replied, 57 job seekers replied. The survey's
questions and answers were reviewed one by one at the
meeting.

E. Dialogue with Arizona Western College

- Staff from YPIC met with Dr. Glenn Mayle from AWC, to have a dialogue to explore the concept of career pathways; from our program to the community college.
- Will try to set up a pathway so people coming out of WIA program can continue education at AWC; looking at long term improvement.

F. Success Stories

- Presented two Success Stories that were introduced at a Board of Supervisors' Meeting from Yuma County.
- **G. Proposed Next Meeting- February 12, 2014** at the Martin Luther King Center located at 300 S 13th Avenue, Yuma, AZ.

John Morales welcomed Abel Almanza as the new Board Member of the Workforce investment Board. John also announced that there are two more new members: Skip Avery from ALSCO, and Julio Bermudez from KSWT-TV.

VII. Discussion/Action items

A. Approval of Training Programs/ Eligible Training Provider List

Sam Pepper asked for approval of the following training programs to be included in the Eligible Training Provider List (ETPL): Agriculture Occupational Certificate, Carpentry Certificate, Early Childhood Educational Certificate, Family Childcare Education Certificate, Industrial Graphics Drafting/CAD Certificate, Infant & Toddler Education Certificate, Network Certificate, Law Enforcement Training Academy, Paralegal Certificate, and Plumbing Technology Certificate.

Ken Rosevear made a motion to approve the recommended training programs

and list them in the Eligible Training Provider List; Seconded by Tom Tyree.

Sam Pepper explained that the Budget and Personnel Committee serves as the ETPL Committee and they reviewed the training programs information; the committee is recommending that the Board approve the training programs presented.

The motion carried.

- On January 29th the Yuma Manufacturing Association will meet at AWC & NAU; they will receive a tour of the new Engineering department and receive information on the new curriculum pathways for employers (from High School to AWC).
- Julie is working with Tom Tyree; Tom is a member of the

AMP Program; they met with the Manufacturers Extension Partnership (MEP). The team will also be presenting to the Yuma Manufacturers Association.

- Several projects were active in December, foreign direct investment towards transportation.
- The county was awarded two grants- One grant is for the Port Authority, and the EDA grant goes to three entities to grow manufacturing.
- Learned in a public hearing that California is investing in economic development by building an over one million sq. ft. of industrial space.
- Arizona was not selected as one of the six testing sites for Unmanned Aircraft Systems (UAS).





Did you accept resumes and applications at the Yuma Community Job & Education Fair?






How many applicants have you hired or do you expect to hire from Yuma Community Job & Education Fair?




Was the time of six hours sufficient for your recruitment efforts?



Is it likely that you will participate in the next Yuma Community Job & Education Fair in 2014?




