Does your data drill down to the zip codes for specific industries? (i.e. welders in north valley)	<ul style="list-style-type: none"> ○ GPC does not but the Greater Phoenix Council or Office of Economic Opportunity might.

Interested in learning more on the GPC healthcare collaborative. Interest in learning more. Are you focused on the delivery of healthcare?	<ul style="list-style-type: none"> o Yes, the focus is the delivery of healthcare, primarily the hospital systems.
Is there a specific age of your target market?	<ul style="list-style-type: none"> o Focus is primarily high schools (CTE) and underserved communities to make the impact for the kids that need the services.
How did your collaborative start?	<ul style="list-style-type: none"> o Through strong leadership and commitment from our business community. Building those strong relationships.
The City of Phoenix was able to contribute funding to the ElevateEdAZ program to expand service within schools. Have seen great success with the program. Wishing there was more funding to expand further.

Should we include Workforce Arizona Council (WAC) Chairman Mark Gaspers to lead the WAC perspective during the panel discussion?	<ul style="list-style-type: none"> o Agreement on suggestion.

Breakout Session Reporting timeframe looks to be a bit tight.	
Likes the Next Steps. Would like to see next steps and how we hear about how we are progressing.	
Which industry partners are being invited?	<ul style="list-style-type: none"> ○ The invitations have not yet been developed, however looking at workforce development, economic development, education and business partners. ○ The three regions (Phoenix/Pinal/Maricopa) will invite the in-demand industry business partners. Hoping the majority of business category Board members, along with other business community partners, would attend.
This Forum will continue the “day two” discussions from the 2023 Arizona Regional Workforce Summit.

What challenges does the Service Provider see in these regional efforts topics of discussion?	<ul style="list-style-type: none"> ○ The Service Provider works with the Maricopa County Head Start program for job seekers who identify childcare as a barrier. For job seekers who have children 5 and older – we connect them with subsidized childcare. It would be beneficial if there was a system that would note which childcare facilities have openings.
With the regional Service Providers in continued contact with one another, are there any areas where you feel collaboration is happening and is there room for opportunities?	<ul style="list-style-type: none"> ○ Opportunities in all areas but much improved in the last few years. However, job fairs is an immediate opportunity to work together regionally. ○ Regional job fair opportunity due to opening of available facility. (May 8th East Valley) ○ Rapid response collaboration has been success between Maricopa County/City of Phoenix/State.
Opportunity to collaborate on job fair for LG plant opening in Queen Creek. We will be inviting regions to participate, including community colleges and high schools.	

Opportunity for businesses to see a conformed effort by ARIZONA@WORK.	
Possibly look at modifying “Regional Job Fairs” to expand to “Regional Business Services” (i.e., job fairs, apprenticeship opportunities, etc..)	<ul style="list-style-type: none"> ○ Agreement on suggestion. ○ Will be hosting a Youth Apprenticeship Accelerator on May 8th.
Regional collaboration on individual Local Plans by using regional language to build upon additional opportunities.
