## VI. Director's Report and Information Items

John Morales introduced and welcomed Tim Tucker from the Department of Economic Security to the Workforce Development Board.

#### A. Washington Update

John Morales reported:

• On April 15, 2016, the director received that Training and Employment Letter (TEGL 17-15) outlining the allocations for the program year. The State of Arizona received a 9% increase for the Adult and Youth and an 11% increase for the Dislocated program program. The allocation looks good for Yuma County.

#### B. State Update

John Morales reported:

- On May 10, 2016, the State released the Proposed Allocation for the local areas.
- On May 25, 2016, the Local Directors of Arizona will be meeting in Phoenix to review the allocations and come to a consensus. The directors usually select the options that will do the least amount of harm to the local areas.

• On May 26, 2015 the allocations will be presented to the Workforce Arizona Council and they will select the options for approval.

# D. Update on Review of Section 1, 2, and 3, of the WIOA Plan

John Morales reported:

- On April 22, the Local Plan Development Team met and reviewed and approved sections 1 – 3 of the WIOA Plan. John Morales thanked Board Member Kevin Wilkins for attending the meeting on his day off to assist and provide important economic development information that needed to be added to the plan.
- On May 6, 2016 the team met again to review and approve sections 4 6. John Morales thanked Board Member Judith Castro for providing recommendations on ways to improve the delivery of information for those sections.
- The Local Plan Development Team will be working on section 7 13. The team is scheduled to meet on Friday, May 20, 2016.

## E. Youth Request for Proposal – Action Item

John Morales reported:

- The Youth Request for Proposal (RFP's) issued in March received only 1 response to provide Youth and Young Adult Services.
- The timeline for the Youth Request for Proposal is as follows:
  - o RFP was released on March 14, 2016
  - The Technical Assistance Session was scheduled on March 23, 2016
  - o The RFP Process closed on April 15, 2016
  - The Proposal Review Committee which is comprised of 3 Arizona@Work Staff and 2 board members reviewed the proposal on May 3, 2016
  - The RFP is an action item that will be voted on later during this meeting.

## F. Council Member Team Renewal Update

John Morales reported:

## G. Youth Request for Proposal Update

John Morales reported:

- The Yuma Education Advocacy Council is a business group formed to advocate for education in the community. The Arizona@Work Executive Director has been asked to sit on the council board. He is asking for the board members to support for Prop 123.
- Prop 123, if it passes, will settle a years-long lawsuit and put funding into Arizona's public schools over the next 10 years without raising taxes.

## H. Additional Funding Update (\$156,070.00)

John Morales reported:

- The Local Workforce Development Board recently received notice from the State of Arizona that some other Local Areas did not spend their funding in a timely manner. Therefore, some of those funds are available for Yuma County. We have requested and received \$156,070. This funding must be spent by June 30<sup>th</sup>.

#### **Charter High School Board, Report:**

Ed Ford reported:

- Security upgrades have been added to the Charter High School. Electronic door locks have been placed at the school. Staff will be using a remote to lock or unlock the front during school hours.
- Arizona Southwest Patrol has been hired to patrol the campus as well as the Arizona@Work grounds.
- The Student Council funds have increased. A scholarship will be provided at the Charter High School Graduation.
- The EOC Charter High School graduation will be taking place on Thursday, May 19, 20016 at the Historic Yuma Theater at 6:00 pm.
- The Budget is 83% expended.
- The State continues to work very diligently to rectify the glitches on the student information system (Synergy). Other schools are having the same issue. The school will contact the State Legislative Representatives to assist in obtaining State funds that have been withheld before the end of the fiscal year.

- The 2015-2016 Budget Amendment was approved.
- The Special Education Policy and Procedures were approved.

## JTED:

Kevin Imes reported:

- The Prop 123 funds, should it pass, will directly influence this year's funding. It would affect school districts planning processes and allow them to hire teachers for next year.
- A student from the EOC Charter High School, who enrolled in the JTED Dual Credit Class AWC, is doing a paid internship through McCarthy and is doing very well. He will be attending training in Phoenix as part of the internship.
